### It's official!

In March, University of California President Mark Yudof issued a statement formally recognizing retiree and emeriti associations as "affiliated organizations" as defined by Regents Policy. The policy acknowledges the service of volunteer groups and encourages their support of the university, recognizing their "valuable assistance in fundraising, public outreach and other support for the university's mission."

Deanna Falge Pritchard, UCDRA representative to CUCRA, the Council of University of California Retiree Associations, supplied a bit of background for the policy's development.

A policy to provide formal recognition was completed at UCLA in 2011, and announced at the CUCRA/ CUCEA meeting in April of that year. Because of similar interest on other campuses, a proposed systemwide policy was developed with leadership from John Sandbrook, chief of staff for President Yudof; Geoff O'Neill, assistant vice president, Institutional Advancement; and Cheryl Lloyd, director of liability at the UC Office of the President. CUCEA/CUCRA and the UC Office of the President then proceeded to move the policy through to final approval.

The critical passage of President Yudof's statement says, "While the retiree and emeriti associations have a long and distinguished history of service to the university, there has not been a formal recognition of the relationship between these groups and the university. Effective immediately, emeriti associations and retiree associations, including the Council of UC Emeriti Associations (CUCEA) and the

Guerren Solbach, UC Davis health care facilitator, will preview Open Enrollment changes for health and welfare benefits.

Several Retiree Center partners, including the UC Office of the President, the Department of Campus Recreation, the Osher Lifelong Learning Institute will provide information. Atria Covell Gardens will generously donate refreshments.

# Recap of UCDRA/UCDEA activities for 2011-12

Outgoing presidents Ted Hillyer and Bill Rains each reviewed their association's activities at their spring annual meetings. Jointly, the associations published three issues of Campus Connections newsletter, organized three general meetings, seven noon talks, and the holiday luncheon. Representatives from both the UCDRA and UCDEA were nominated for several UC Davis committees and taskforces, including the Chancellor's 2020 Initiatives task forces. Finally, the associations donated funds for lobby furniture to be placed in the Retiree Center and provided both volunteer and financial support for many center-sponsored day trips and events, such as the Steak Bake and the New Retirees Reception.

UCDRA focused on making organizational processes clearer and more effective, from development of a new mission statement to clarification of board structures; developed

a new board orientation; and began formation of a long-range planning committee. A Facebook page and a new membership brochure were created to improve communication with members and outreach to prospective members. Continuing activities for the association included awarding a \$1,000 staff scholarship and honoring three exceptional retirees, who rode in a horse-drawn carriage in the Picnic Day parade.

The UCDEA video records committee completed 15 new interviews of retired faculty and administrators to enhance the campus' oral history record and made DVDs of most of the previously recorded interviews available to both the campus library and DCTV's website, where they will have much greater visibility. To make it easier for new emeriti to find out about the association and its activities, a group redesigned the UCDEA brochure.

# UCDRA Staff Scholarship awarded

Donna Glaeser, an animal health technician at the Veterinary Medicine Teaching Hospital is the 2012 recipient of the \$1,000 staff scholarship awarded by the Retirees' Association. Donna completed her undergraduate degree in Animal Science at UC Davis in 1996 and joined the VMTH in 1998. She is enrolled in an accelerated second bachelor's degree program in nursing at California State University, Sacramento, and is on schedule to complete her degree and qualify as a registered nurse in May 2013.

Ms. Glaeser works graveyard shift in the Small Animal Intensive Care Unit of the Veterinary Medical Teaching Hospital in order to attend classes during the day. Having advanced to the top of her classification while continuing to provide direct patient care, she hopes to continue with the university, but at the Medical Center in Sacramento working with human patients.

The staff scholarship is based on a competitive application process, funded by the UCDRA, and completed in collaboration with the UC Davis Staff Assembly. Ms. Glaeser will receive her award at a fall ceremony along with other Staff Assembly winners. When her selection was announced at the September UCDRA Board meeting, her ambition and dedication to patient care were warmly applauded.

# Call for UC Davis Distinguished Emeritus/a Award

The UC Davis Distinguished Emeritus/a Award honors outstanding scholarly work or service (e.g., service in professional, university, Academic Senate, emeriti/ae, departmental, or editorial posts or committees) performed since retirement by a UC Davis emeritus/a. Deans, the provost, and UCDEA members may submit nominations for the award. Please submit nomination letters to the chair of the Awards and Recognition Committee, care of Marjorie Ahl at the UC Davis Retiree Center (mahl@ucdavis.edu).

Nomination letters should outline the nominee's distinctive scholarly work and/or educational service since retirement. Nominations should also include a copy of the nominee's CV and three references who can comment specifically on the nominee's achievements since retirement. Nominations must be submitted electronically by 5:00 p.m. on Tuesday, November 13.

Distinguished Emeritus/a Award recipients receive a plaque and a cash award of \$1,000. The award will be announced at the Chancellor's Emeriti and Academic Retirees luncheon in January 2013.

# **Emeriti welfare news**

You may have heard or read that the California Legislature has passed and Governor Brown has signed a pension reform plan. Be aware, however, the legislation does not apply to University of California employees, who are covered by a separate university pension plan. Among other changes, the new plan will require many state workers to pay higher pension contributions and will increase the retirement age at which new employees can receive maximum retirement benefits.

Some recommendations made by the UC Post-Employment Benefits Task Force and approved by the regents that do affect the UC pension plan and health benefits will be implemented on July 1, 2013. These changes apply only to new hires or current employees and not to retirees. However, the director of the systemwide Human Resources Office has appointed a task force to continue to study ways in which employee/retiree health care costs can be reduced or at least contained. We will continue to monitor the work of this task force and report on proposed changes which would affect retirees.
