Bob Halferty reported that he sent an e-mail to all Board Members asking for approval of the amended UCDDA bylaws. Response was unanimous approval. Bylaw revisions will now go to the general membership for approval at the May meeting.

Spring General Meeting: Yvonne Marsh indicated that Lor Shepard will be guest speaker. The title of his talk is "Applying Investment Principles in Scary Times." The meeting is co-sponsored by UCDEA and UCDDA. Following the meeting, a tour of the Schaal Aquatic Center has been arranged. **Emeriti Association**

Dick Walters reported that the Executive Committee will meet following Thursday's luncheon. The UCDEA general meeting is scheduled for May 22, 3:00-4:00 PM. UCD Nutritionist Liz Applegate will be the featured speaker. Walters indicated that his term as president ends June 30. Alex McCalla will assume the office July 1. Walters will serve on the membership committee. He said that a mechanism is now in place where academics—non-Academic Senate--can apply for emeritus membership at anytime.

### **Treasurer's Report**

According to Carol Kurtz, since her last report \$90 has been collected with no expenses incurred for a balance of \$10,929.29, plus three new members. Total membership stands at 509.

### **Scholarship Committee Report**

Corinne Cooke apprised the group on the history of the scholarship program and its process. Because of a change in personnel, no awards were given last year. This year, eight employees applied, two of whom appear to be prime candidates. UCDRA will be awarding scholarships in the amount of \$500 to each of the prime candidates, for a total of \$1000. The recipients will be informed by letter. It appears that RA has not been given credit for funding these scholarships. Perhaps the recipients could be invited and recognized at a general meeting.

A motion was made by Yvonne Marsh and seconded by Aggie Costantini that two \$500 scholarships be awarded. Motion carried.

It was suggested that a manual be prepared which would contain procedures and supporting documents; i.e. copies of the call for applications, award letters, etc. This raised the issue of better record keeping for each of the standing committees. We need a better "paper trail." Operating procedures for each of the standing committees needs to be established.

In the absence of Bob Bynum, Bob Halferty indicated that the newsletter is at Reprographics.

### **Membership Committee Report**

Aggie Costantini said that brochures went out last year along with letters to those whose memberships had fallen off the last two years. Response was good. Another "lapse" letter and the newest brochure will be sent out.

In regards to the brochure, Doreen will meet with the designer on Wednesday morning. The original designer will make the changes (at a cost of about \$100) and then Express Scripts will print 5000 (cost \$566 plus tax).
