Old Business

By-Laws Committee

Beverly Brooks reviewed the proposed by-law changes. After some discussion concerning wording, a motion was made by Ted Hiller, seconded by Jim Wilson, and approved.

Those changes as recommended by the By-Laws committee read as follows. They will be presented to the General Membership for a vote at the May 3, 2010 meeting. (**Deleted Material indicated by bold print in parenthesis**), <u>added material indicated In Italic and underlined.</u>

<u>Article V – Officers</u>

Section VI. (**Historian:**) <u>Archivist</u>:

<u>Article VI – Committees</u>

Section III. **Membership Committee**:

At the end of this paragraph the following line will be added.

<u>The Membership Chairperson shall serve on the Public Relations</u> Committee.

Section IV. <u>Public Relations Committee: This Committee shall seek ways to increase membership and attendance at University of California Davis Retirees'</u>
Association (UCDRA) and Retiree Center events and programs by promoting
UCDRA to potential members, extending knowledge of the association and its
activities to the greater campus community and University of California Health
System (UCDHS), by increasing visibility via its website, local and regional
newspapers and other media as

appropriate. The committee shall provide oversight and assistance as requested to Emeriti and Retirees' Association newsletter, "Campus Connections." The Committee shall be comprised of a member from the Executive Board, the Membership Committee Chairperson, at least (2) two members at large, and the Editor of the "Campus Connections" as an ex-officio member.

The below Section under **Article VI** will be changed from Section IV to Section V

Section V. Other Committees:

Article XIV – Representatives to Council of University of California Retirees' Associations

Section I. **Appointment:**

- A) (At the first meeting following election of Officers and Board Members, the Executive Board shall appoint two representatives to the Council of University of California Retiree's Associations. Representatives shall attend the semi-annual meetings of the Council.)
- B) (Initially, one representative shall be appointed for a two-year term as voting representative. A second representative shall be appointed for a three-year term as an alternate representative for the first year and for a three-year term, with the first year as an alternate and the second and third years as a voting representative.)

The following is the proposed change:

Article XIV – Representation at Council of University of California Retirees' Associations

Section I. **Appointment:**

At the first meeting following election of Officers and Board Members, the Executive Board shall appoint a representative, to vote on behalf of the Association, and an alternate to the Council of University of California Retirees' Association (CUCRA). Each appointment shall be for (2) two years (1) one year as alternate and (1) one year as a voting representative and shall be renewable. The representative and the alternate shall attend the semi-annual meetings of the Council. If the representative is unable to attend, the alternate shall vote on behalf of the Association.

New Business

Y. Marsh discussed the merits of whether the Association should be voicing their opinion about UC's budget and whether they should take a stand. Don McNary has

found that individual, rather than group, letters to a representative in the Legislature is more influential.

Because there is no room available at the Medical Center, the April 5 Executive Committee meeting, will be on campus. It was suggested that Bob Chason be invited to become a member-at-large representing the Medical Center.

Steak Bake. The event is planned for Saturday, June 7 from 5:00 to 7:00 p.m. The Retiree Center no longer has the funds to underwrite any costs. Actual cost for facility, food and wine is \$46.00/person. The Center wants to keep the cost down to \$40.00/person which equates to the Association paying \$6.00/person. Aggie Costantini believes that the Association should not be subsidizing individuals for the event. It was suggested that rather than the "per person" amount, a portion of the total event be paid by the UCDRA.

A motion was made by Estell Jones and seconded by Lew Dudman to authorize an expenditure of \$300-\$500 range to underwrite the cost of the Steak Bake. Motion carried.

There being no further business, the meeting was adjourned at 2:45 PM
