February General Meeting

Retirees are urged to attend the February General Meeting (a joint meeting with the Emeriti Association) from 2 to 4 PM on Monday, February 2nd in Ballroom A of the ARC Facility to hear a presentation by Gary Schlimgen Director of Retirement Policy and Planning in the UC Office of the President. Mr. Schlimgen will speak on the structure, management and long term outlook of the UC Retirement Fund, as well as the impact of the current financial situation on the fund's stability. This is an extremely timely discussion on the status of our UC Retirement Program and all retirees should consider attending in order to hear directly from its director.

Parking Privileges

As many readers are aware, the campus administration is currently reviewing the continuation of free campus parking privileges for retirees and emeriti. It has been the tradition of the campus for nearly 50 years to provide free parking to retirees. Because of the severe budgetary reductions being imposed on the campus by the State, all campus programs are being reviewed for budgetary savings purposes. The Retirees Association and the Emeriti Association are currently in discussions with the administration on this issue.
